## Terms and Conditions for Hospice Malta Lottery

### **Organisers:**

The lottery is organized by Hospice Malta, a registered charitable organization in accordance with the laws of Malta, in compliance with the Malta Gaming Authority (MGA) regulations. Hospice Malta is also a Non-Governmental Organization (NGO) enrolled with the Commissioner for Voluntary Organisations (VO/0062).

### **Eligibility:**

Participation in the lottery is open to individuals aged 18 years or older, who are residents of Malta. Board members of Hospice Malta are ineligible to participate.

### **Lottery Tickets:**

Lottery tickets will be sold from the 16<sup>th</sup> September both through the traditional printed tickets and online through Hospice Malta's official website. Each ticket will be assigned a unique number. Online tickets can be purchased through the Hospice Malta website. Upon successful completion of the purchase and payment, an online ticket number will be generated, and the purchaser will receive an online ticket/receipt via email. The online ticket number generated will be printed on a physical stub of the same size as the physical tickets sold through other channels. This printed online ticket stub will be placed in the lottery urn along with the other physical tickets for the draw.

### **Ticket Price:**

The price of a single lottery ticket is €1 and will be clearly communicated to participants at the time of purchase. Payment for the tickets must be made in full at the time of purchase and is non-refundable. Payments for lottery tickets can be made either online, by cheque by post or in person at the Hospice Malta offices (and online payment for the online tickets). All payments must be made in the local currency (Euro) and should be received before the lottery draw date.

**Lottery Period:**

The lottery period will be Q4 of 2024, and the lottery draw date will be on the 3<sup>rd</sup> December 2024 at 11am specified. Tickets purchased or returned after the 29<sup>th</sup> November at 9am will not be considered for this particular draw.

**Termination and Exclusion of Participants:**

Owing to exceptional circumstances outside its reasonable control and only where circumstances make this unavoidable, Hospice Malta reserves the right to cancel or amend the Prize Draw or these Terms and Conditions at any stage but will always endeavour to minimize the effect on participants in order to avoid undue disappointment.

**Prize Draws:**

There shall be total of five (5) winners.

The following are the prizes that will be awarded by Hospice Malta following the Prize Draws:

First drawn - A 2-night stay for 2 persons in a Deluxe room including breakfast at AX The Palace Malta.

Second drawn - A Samsung 55" Smart Television from Sound Machine.

Third drawn – A Daikin 12,000 BTU Air conditioner from M.A.A.

Fourth drawn – A €2,500 cruise voucher from The Cruise & Travel Group.

Fifth drawn - A brand new electric LeapMotor T03 from Motors Inc.

The winners will be selected through a random draw from all eligible entries received during the lottery period. The draw will be conducted in a fair and transparent manner, and the results will be publicly streamed and announced live through Hospice Malta's facebook page and via a press release which will be sent out to the press within three working days after the draw date. The draw will also be transmitted live on the Hospice Malta facebook page.

All prizes are non-exchangeable and not refundable. The prizes will only be awarded to named authorised winners. Each name drawn shall be contacted by Hospice Malta on the landline/mobile number provided on entry ticket within 2 working days from the Prize Draw. Each Winner shall be required to fill in and sign a declaration form that they are accepting the prize and send an image of their ID card. Winner must also present the drawn ticket in person at Hospice Malta's offices.

The car presentation will be held on the 11<sup>th</sup> December at 11am at Motors Inc. showroom, Mdina Road, Qormi. The LeapMotor T03 must be registered by the 31<sup>st</sup> December 2024, to fully qualify for the electric vehicle grant. Failure to register the vehicle by this date may

result in the forfeiture of the government grant, in which case the winner will be responsible for covering the amount originally subsidized by the grant or may choose to decline the prize. Road license and number plates of the winner of the car are to be paid by the winner. Car insurance is to be paid by the winner a week before delivery/collection of the said car.

**Prize Collection:**

Winners will be notified via the contact information provided at the time of ticket purchase. Winners must claim their prizes within 30 days of the draw date apart from the LeapMotor T03 car as this must be claimed within 7 days of the draw date. The right of claiming winnings shall be barred by the lapse of thirty days (for the second, third, fourth and fifth prize) and seven days (for the first prize) from the date of the respective drawing.

Unclaimed prizes shall become the property of Hospice Malta and may be used for charitable purposes as per the organization's discretion.

**LeapMotor T03 Electric Grant**

1. **Grant Refund Obligation:**
  - The winner of the LeapMotor T03 must refund the electric grant to Motors Inc. within one year from the date of vehicle registration.
2. **Forfeiture of Prize:**
  - Failure to refund the grant within the specified one-year period will result in the forfeiture of the prize.

  - Motors Inc. reserves the right to secure a guarantee in its favor through a bill of exchange for an amount equal to the grant to ensure compliance with the refund obligation.

These Terms and Conditions shall be governed by the laws of Malta, and any disputes arising under or in connection with the lottery shall be subject to the exclusive jurisdiction of the Maltese courts.

**Modification and Termination:**

Hospice Malta reserves the right to modify or terminate the lottery at any time, for any reason, without prior notice. In the event of termination, participants shall be entitled to a refund of the ticket price.

**Personal Information:**

Participants' personal information collected during the lottery will be handled in accordance with Hospice Malta's privacy policy and will be used solely for the purposes of the lottery and related communications.

By purchasing a ticket and participating in the lottery, participants agree to abide by these Terms and Conditions and all decisions made by Hospice Malta in connection with the lottery. These Terms and Conditions shall prevail in the event of any conflict or inconsistency with any other communications related to the lottery.
